## **IMPORTANT TAX NOTICE**

Re: 2023 PFIC Status

This statement is provided for shareholders who are United States persons for purposes of the U.S. Internal Revenue Code who held Pref D shares in FTAI Aviation Ltd. ("FTAI" or the Company") during the 2023 calendar year.

## Overview

On November 10, 2022, Fortress Transportation and Infrastructure Investors LLC completed the merger transaction with FTAI and FTAI Aviation Merger Sub LLC. Upon the effective date, Fortress Transportation and Infrastructure Investors LLC liquidated and Fortress Transportation and Infrastructure Investors LLC shares were exchanged for shares in FTAI.

FTAI meets the Internal Revenue Code definition of a passive foreign investment company ("PFIC") for the taxable year ended on December 31, 2023. The Company is hereby making available PFIC Annual Information Statements for its taxable year ending on December 31, 2023, pursuant to the requirements of Treasury Regulation Section 1.1295-1(g)(1).

The PFIC Annual Information Statements contain information to enable you to comply with any Qualified Electing Fund ("QEF") elections.

A U.S. shareholder who made a QEF election for FTAI is required annually to include in their income their pro rata share of the ordinary earnings and net capital gains, if any, including for the taxable year in which FTAI shares were disposed.

U.S. shareholders are advised to consult with their tax advisors with respect to the 2023 PFIC Annual Information Statement.
